Financial Commitments

Financial commitments are generally tiered based on level of involvement. Additional options may occur on a case-by-case basis:

- 1. Executive Leadership Team: \$50,000 annually
- 2. Steering Committee: \$6,500 annually
- 3. Working Group Lead: \$2,500 annually
- 4. Organizational: \$500 annually
- 5. Non-Profit: \$100 annually (minimum)
- 6. Individual: \$50 annually

South Sound Military & Communities Partnership (SSMCP)

Executive Leadership Team: \$50K

The ELT shall act for and on behalf of the Steering Committee when the Steering Committee is not in session. SSMCP Staff:

- · Program Manager
- · Program Coordinator

Steering Committee: \$6.5K

The Steering Committee is the primary decision-making body of the organization and provides broad oversight to the implementation of the recommendations, strategies and action items outlined in the Growth Coordination Plan and successor documents.

Working Group Lead: \$2.5K

Working groups, task forces, and/or other such committees may be established by the Steering Committee as the Steering Committee deems necessary and pursuant to the MOA. Elected Officials Council:

All elected leaders in the South Sound region which elect officials shall be invited to participate on the EOC.

The EOC shall convene 2-3 times annually to receive updates on military and community issues, review the annual work plan, coordinate legislative strategies, and suggest outreach efforts to maintain a high level of visibility for these priorities.

Organizational: \$500

The purpose of the organizational membership is to provide expertise, perspective and guidance to the Steering Committee on specific topics that promote the objectives of the SSMCP.

Non-Profit: \$100

Non-Profits provide expertise, perspective and guidance to working groups on specific topics that promote the objectives of SSMCP. Individual: \$50

Individual community members may join to be a part of SSMCP and support the objectives of SSMCP.

2016 Fall Elected Officials Council Review

Elected Officials met 8 December 2016 to hear and vote on the SSMCP 2017-2018 Work Plan and 2017 Legislative Agenda. The approved tasks and legislative items include areas of focus to improve the South Puget Sound region. Stakeholders are encouraged to voice their support of the legislative agenda. SSMCP staff are available to provide greater detail regarding current and planned progress upon request. See the latest documents at www.ssmp.org.

2017-18 Work Plan Tasks

1. Implement the 2015 JBLM JLUS recommendations

- •JLUS implementation began in 2016. SSMCP assists local jurisdictions in integrating the study's land use recommendations.
- 2. Develop a path to resolve JBLM North Clear Zone Encroachment
- Obtain funds and collaborate with JBLM to identify an acceptable method to resolve CZ encroachment.
- 3. Monitor & Support Transportation Improvement Efforts South of the JBLM Corridor
- •\$495M of 2015 WA Transportation Package dedicated to I-5 Corridor from Lakewood to DuPont. Seek \$5M to study anticipated I-5 traffic congestion between exits 116 & 99.
- 4. Enhance & Expand Regional SSMCP Coordination & Participation
- •SSMCP collaborates with regional partners to inform and facilitate integration of military-support activities.
- **5.** Educate stakeholders on military impacts across the South Puget Sound
- •SSMCP promotes military related economic and business development initiatives with legislators, regional planning bodies, & local jurisdictions
- 6. Participate and Advocate in State Level Activities
- •SSMCP participates in the state-level Washington Military Alliance as well as advocates for regional needs to legislative bodies.
- 7. Conduct Periodic JBLM Community Survey, Circulate Results
- •2016 survey gathered data from JBLM service members with a focus on military economic impacts on the community and perceptions of life in the South Sound.
- 8. Support Active Duty, Veteran & Military Family Workforce Development, Healthcare, & Social Services
- •Social Services and Healthcare working groups facilitate communication

2017 Policy Positions

Maintain Active State support for Military Affairs in Washington: SSMCP believes in a strong commitment from the State in support of military affairs. Continuing to support the Washington Military Alliance (WMA); recognizing and protecting the economic benefit realized in the State by government and the private sector due to our military's presence.

Direct Compliance with the REAL ID Act: SSMCP encourages Washington State to pass necessary legislation to comply with the Department of Homeland Security REAL ID requirements. The Act establishes minimum security standards for state-issued driver's licenses and identification cards and prohibits Federal agencies from accepting, for official purposes, licenses and identification cards from states that do not meet these standards.
